ORDER GRANTING PLAINTIFF CHARCOT-MARIE-TOOTH ASSOCIATION'S MOTION FOR TEMPORARY RESTRAINING ORDER AND INTERLOCUTORY INJUNCTION

This matter came before the Court on March 24, 2021, on Plaintiff Charcot-Marie-Tooth Association's ("CMTA" or "Plaintiff") Motion for Temporary Restraining Order and Interlocutory Injunction (the "Motion") against Defendants CMT Research Foundation, Inc. ("CMTRF") and Susan Ruediger (collectively, "Defendants").

On March 9, 2021, CMTA filed its Verified Complaint for Damages and Injunctive Relief (the "Verified Complaint") and the Motion, supported by a Memorandum of Law and the Affidavit of Molly Adams. Defendants CMTRF and Susan Ruediger were given actual notice of the Verified Complaint and Motion and filed a Response in opposition to the Motion on March 22, 2021 ("Response"). Based on the Court's review of the Verified Complaint, the Motion and supporting documents, including the Affidavit of Molly Adams, and the Response, and after hearing argument from counsel, the Court GRANTS the Motion.

Having considered whether there is a substantial threat that Plaintiff will suffer irreparable injury if an injunction is not granted, whether the threatened injury to Plaintiff outweighs the

threatened harm an injunction may do to Defendants, whether there is a substantial likelihood that Plaintiff will prevail on the merits of its claims at trial, and whether granting an injunction will disserve the public interest, the Court finds that the immediate relief requested by Plaintiff is necessary to preserve the status quo and avoid immediate and irreparable harm pending a trial on the merits.

Accordingly, it is hereby ORDERED AND ADJUDGED that Defendants, and anyone acting in concert or participation with them, are ENJOINED from using the Donor List¹ or the information in the Donor List in any way; that Defendants are ORDERED to immediately return the Donor List to CMTA, including all derivatives of the Donor List; and that Defendants, and anyone acting in concert or participation with them, are ENJOINED from contacting individuals identified on the Donor List; however, nothing herein shall prevent Defendant Ruediger and CMTRF from benefitting from the use of their intangible knowledge, information and skills or from CMTRF's own development efforts (unaided by the Donor List) for the purpose of identifying and locating potential donors for CMTRF.

This injunction shall remain in effect until further order of the Court.
